## About Age Concern Auckland

Age Concern Auckland is a charitable organisation dedicated solely to the over 65s and is one of the most significant providers of services across Auckland that connects, supports, empowers, celebrates and respects the older people in our community.

### Our work is divided into four key areas:

- 1. Intervention Services** that support older people suffering from abuse, neglect and in need of social support.
- 2. Ageing Well Services** that assist older people to stay independent, healthy and active.
- 3. Social Connection Services** that mitigate loneliness, promote community involvement and enable mobility.
- 4. A dedicated Asian Service** to meet the needs of the growing older Asian community, that provides services and support in Mandarin and Cantonese.

We also inform local bodies and organisations on issues of concern for older people, ensuring older people are heard and represented in their communities.

We provide services across Auckland and each year we receive tens of thousands of requests for help.

## Emmett's\* Story

We were contacted by the GP of Emmett, an older gentleman, who was living in a rental. The GP was very concerned about Emmett's living conditions as his unit was extremely cold and damp. There was also unsafe access to the unit as Emmett had to enter his home via 30 very steep steps.

Age Concern's Field Social Worker met with Emmett a number of times and we worked together and applied for social housing for Emmett. With our advocacy and support Emmett has been rehoused in a Housing NZ pensioner village, safe and warm, and paying a third of the rent that he was previously paying. This is a great outcome for Emmett and was only possible with the support of Age Concern Auckland.

## Leaving a gift in your will

Leaving a bequest is easy. After taking care of loved ones, the simplest way to leave a gift in your will to Age Concern Auckland is to speak with your solicitor. They can ensure that your estate is distributed in a way that honours your wishes.

Bequests can be made a number of ways, depending on your wishes and circumstances.

**Residual** – a gift from the remainder of your estate, once your loved ones have been provided for and any taxes and charges settled.

**Percentage** – a gift of a specified percentage of your estate.

**Specific** – a specified amount of money, item of property or stocks or shares.

### Recommended Wording

To leave a bequest to Age Concern Auckland we recommend this wording:

"I give Age Concern Auckland Incorporated the sum of \$X (or the residue of my estate, or a percentage of my estate) for its general purposes. I declare that the official receipt of Age Concern Auckland will be sufficient receipt and discharge for my trustees."
